

PUBLIC CONSULTATION ON OSIDGE LANE



We are continuing our consultation that started in March 2021 and we are grateful to everyone who has taken part and provided feedback so far.

The current PDSA Pet Hospital in Hendon will need to be relocated, and the council owned car park on Osidge Lane has been identified as a potentially suitable location. Our aim is that it will be designed to meet PDSA's requirements.

As part of our continuing consultation we have identified a number of potential changes that could be made to the proposals, responding to the feedback that we have received. Information about these changes is available on the project website and will be discussed at our upcoming virtual events (see right).

Whilst our consultation is ongoing, we have listened to the feedback received so far. One option we are considering is to remove the Osidge Lane site from the Hendon Hub project altogether. The new Pet hospital would in that case be relocated to an alternative site.
